- 4) LESSEE agrees to conduct himself (herself) and family in an orderly and lawful manner. TV is confined to the house. Any music played on the pier or in the yard should be acceptable to nearby neighbors. Loud music will not be tolerated.
- 5) The LESSOR reserves the right to require that the LESSEE vacate the property immediately if there is a breach of this LEASE.
